VIRENT ENERGY SYSTEMS RECEIVES \$7.5 MILLION FUNDING IN ROUND LED BY CARGILL VENTURES

MADISON, Wis., June 8th, 2006 – Virent Energy Systems, Inc. announced today it has raised a \$7.5 million round of private venture financing led by Cargill Ventures. Honda Strategic Ventures, Venture Investors, and Advantage Capital Partners also participated in this round, which will be used for product development and commercialization of its Aqueous Phase Reforming (APR) process.

Virent's APR process offers a cost-effective and thermally efficient method for producing hydrogen, fuel gas, some liquid fuels and high value chemicals using renewable biomass. The company has already demonstrated and sold a system that produces SuperNatural GasTM, a mixture of hydrogen and alkanes to fuel internal combustion engines. By demonstrating the capability of localized, on-demand fuel delivery, the system is a promising first step to providing a reliable method for renewable fuel generation from a variety of widely available biomass sources. With high efficiency and low equipment costs, this low-temperature, direct conversion process can be used for distributed power systems, fuel stations, centralized fuel production or, longer term, mobile applications. The APR systems can be designed to deliver predominantly hydrogen or alkanes (i.e. methane, ethane, propane and butane), or a customized blend of these fuels.

Virent was founded in 2002 by Dr. Randy Cortright and Dr. Jim Dumesic from the University of Wisconsin and already has received nearly \$4.5 million in grants from the Department of Energy and National Institute of Standards and Technology.

"The investments from Cargill Ventures and Honda Strategic Ventures give Virent's technology tremendous global leverage in the emerging biofuels and hydrogen markets. We look forward to working closely with Cargill and Honda," said Eric Apfelbach, Virent's Chief Executive Officer.

"Virent's technology is revolutionary in its simplicity. It allows abundant, bio-based renewable fuels to be used easily and cost-effectively with existing as well as future energy technologies," said Paul Bieganski, Managing Director and CTO of Cargill Ventures.
